<b>Our purposes of processing your personal data</b>	<p>In case you wish to attend the event, the provision of your personal data, as collected on the on-line form, is necessary for us to be able to organize the event.</p> <p>No list of participants will be publicized, but the conference program will be openly available on the conference website.</p> <p>More specifically, we process the personal data we collect from you for the following purposes:</p> <ul style="list-style-type: none"> <li>• Communicating to the attendees</li> <li>• Designing the event programme</li> <li>• Organising and communicating practical matters related to event venues, catering, etc.</li> <li>• Gathering feedback after the event or posting materials</li> </ul>
<b>Legal basis for our processing of your personal data</b>	The collection and processing of your personal data is based on the university’s performance of a task carried out in the public interest that involves research, education and related events.
<b>Recipients of your personal data</b>	<ul style="list-style-type: none"> <li>• Organising teams at the History of Science and Ideas department</li> <li>• All the personal data collected from you will be processed in accordance with the General Data Protection Regulation (GDPR). No data will be transferred outside the EU or the EEA.</li> </ul>
<b>Storage period of your personal data</b>	<ul style="list-style-type: none"> <li>• Full personal information as we collect here: from time of collection until 31.7.2022</li> <li>• Abstracts and event programme (including names and contact details): indefinitely</li> </ul>
<b>Other information</b>	<ul style="list-style-type: none"> <li>• You have the right to request from us access to and rectification or erasure of your personal data or restriction of processing concerning yourself or to object to processing, as well as the right to data portability, as stated in the GDPR.
